## Terms of Use Moodle Learning Management System

## Terms of Use and Data Protection Notice

With the Moodle learning management system, PMCC Consulting GmbH offers a learning platform that aids in the organisation of elearning modules. Accordingly, elements (learning module, downloads, feedback questionnaire, certificate) for a seminar ("course") are made available in Moodle and can be used by the participants.

Only registered users can work in Moodle. Thus, in order to be able to use the e-learning platform, the participants must temporarily provide consent for their data to be processed (this involves the disclosure of the participants' first and last name and valid e-mail address by the company commissioning the seminar, the registration of the participants, and the submission of this data to the PMCC Academy). Registration in Moodle is not possible without this data (constitutes consent).

The use of the Moodle learning management system will lapse after the expiration of the specified licence period, and the participants' consent will lapse upon the cyclical deletion of user data by PMCC Consulting's administrators. In addition, the participants' consent can be revoked at any time before the expiration of these time periods by submitting a corresponding request to the administrators. This information must be provided, because you can only participate in seminars with this data. The personal data listed above cannot be seen by other participants.

Personal data from Moodle may only be transferred to other computers, servers, or files outside of the program for the purposes of the given course. Only the administrators at PMCC Consulting GmbH have access to all of the data created within the Moodle learning management system. They are only permitted to use this data within the narrowly defined scope of their duties. No personal data is shared with third parties in the course of the administration process, not even in an anonymous form. This does not apply to legal disclosure obligations.

You have the right to revoke your consent at any time, to request information about the data about you that is stored, and/or to have incorrectly saved data rectified and to have your data erased.
